- 2. Reviewed accounts receivable as of this meeting date. Delinquencies total \$12.5K of which a unit in foreclosure is \$12.2K of the total amount.
- **3.** Betsy Greiner made a motion to reclass all the negative reserve numbers under Equity on the balance sheet. Nick Pordan seconds and motion carried.

### G. <u>ADMINISTRATIVE & LEGAL:</u>

- 1. Unit 1454 discussion held. There has been an architectural change form submitted to get new windows, front door and storm door. Renewal By Andersen doing the work when the windows and doors come in.
- 2. Unit 1554 has an unlicensed vehicle in their parking space. Cindy asked to send a letter and have the issue resolved.
