### A. PRESENT:

The Board reviewed the mock-up version of the new Rules & Regulations handbook. The edits were submitted, the board approved all the edits and Sue and Joe will read one more time for spelling and grammar and then they will be printed and mailed out the first week of January 2023.

The Board discussed the long-term parking area and how long cars should be allowed to park there. The Board made adjustments in the rules and regulations to shorten the period to 48 hours.
