## A. PRESENT:

Joe Morgante made a motion to accept the Financial report, Jessica Murphy seconded; all were in favor and the motion passed.

**G.** <u>ADMINISTRATIVE & LEGAL</u>: Sue requested if there is a way to analyze the usage the site is getting every month. Joe will look into this request.

#### H. MAINTENANCE:

 Joe Morgante brought up his dissatisfaction with the landscaping and plowing. The board decided to table for a later date.

- Phase I fences will be stained this year along with any fences that had repairs.
- The Board discussed the repairing of the lawns by Thomann Asphalt. Those repairs have been completed and the lawns are growing. The Board also discussed the gas company.
