#### A. <u>PRESENT:</u>

- B. <u>ROLL CALL and/or DESIGNATION OF QUORUM:</u> Quorum Present no roll call necessary meeting started at 5:12 PM
- **D.** <u>SET THE AGENDA:</u> Jessica Murphy made a motion to set the agenda as amended, Joe Morgante seconded the motion; all were in favor.

## F. <u>FINANCIAL REPORT:</u>

- Bob made a motion to move 68,465 out of the M&T Savings account and deposit into the Money Market savings account with Mass Mutual.
- The board discussed the budget for 2024/2025. The budget leaves the monthly HOA at \$295.00/month. Joe Morgante made a motion to accept the budget as presented. Mark Bartholomew seconded the motion, all were in favor and the motion passed.

Deby FoHahn made a motion to accept the financial report, Mark Bartholomew seconded; all were in favor and the motion passed.

# G. <u>ADMINISTRATIVE & LEGAL:</u>

• Architectural - None

- The board discussed the water main break behind unit 1051. Patio replacement will be discussed with the homeowner, along with replacement of her bordering flowerbed.
- Unit 1251 took Charlesgate Village Association to small claims court for sewage backing up in their basement. Both parties mediated the claim and Charlesgate settled by paying the owner \$1,000.00 for unit cleanup.
